


**Abstract:** The current presidential campaign has focused attention on the importance of "character issues." In fact, these issues are part of a more general set of concerns surrounding a leader's suitability for a particular set of leadership roles. This workshop will explore the background and rationale for such concerns and deal with a specific set of questions concerning them: (1) How has the discussion of "psychological suitability" altered the framework of political discourse, (2) how is "psychological suitability" to be defined and assessed and what is its relationship to character, competence, and role requirements, and (3) what implications, if any, do such considerations have for the way in which we select, evaluate, and prepare persons for leadership roles.

**Abstract:** Using John Burton's pioneering work as our starting point, we have developed a third-party approach to conflict resolution--"interactive problem solving"--and applied it primarily in Israeli-Palestinian workshops. While adhering to certain basic principles, workshops can be adapted to differences in purpose, stage of a conflict, institutional context, type of participants, third-party composition, and third-party style. This view suggests research and evaluation focusing on how variations in workshops affect workshop procedures, participant interactions within a workshop, and ultimately changes in workshop participants and the larger conflict system. Within this framework, we will discuss: (1) the effects of such variables as gender of participants and composition of the third party on the nature of interactions in Israeli-Palestinian workshops; (2) adaptation of workshops to conflicts between national/ethnic groups within the same polity, where the third party is drawn from the conflicting parties themselves; and (3) possibilities for experimental investigation of the effects of key workshop dimensions.

Abstract:      This experiential simulation workshop will focus on the inevitable conflicts which occur when national actors, groups, and individuals, each with their own priorities and agendas, attempt to cooperate in the context of an international organization. Drawing on the contributions of Wilfred Bion and the model of the Tavistock Institute/A.K. Rice Institute Group Relations Conferences, the workshop will clarify the manner in which destructive group and organizational dynamics can interfere with achieving organizational cooperation. Drawing on the experience of the prior runnings, this third experiential workshop, while continuing to draw on the Tavistock model, will be expanded by placing the learning task in the structure of an international negotiations scenario. The membership will be divided into three political blocks whose task will be to study

the process by which they attempt to form an international organization.

The workshop will be under the overall direction of Dr. Jerrold Post, Professor of Psychiatry and International Affairs, The George Washington University and Dr. Arthur Colman, President, The A. K. Rice Institute. Members of the workshop staff will be Dr. John Mack, Professor of Psychiatry, Harvard University, Pamela Steiner, Department of Human Development, Harvard University; and Robert Robins, Chair, Department of Political Science, Tulane University, who has spent the 1987-1988 academic year as visiting professor at the Tavistock Institute. Dr. Harold Saunders, former Assistant Secretary of State for the Middle East who helped negotiate the Camp David accords, will provide political consultation to the workshop staff and membership as they attempt to understand the self-imposed barriers to a successful international organizational negotiation.


