



This experiential workshop will focus on the inevitable tensions and conflicts which occur when individuals, groups, organizations and nations attempt to cooperate in the context of an international organization. Drawing on the contributions of Wilfred Bion and the model of the Tavistock Institute Group Relations Conferences, the workshop will clarify the manner in which destructive group dynamics can interfere with organizational cooperation, focussing especially on such phenomena as ingroup/outgroup tensions, attribution of negative motivations to outsiders, organizational boundaries and negotiating roles, etc.

While drawing on the Tavistock model, the workshop will place the learning task in the structure of an international organization. The participants will divide into three groups representing political blocs, the East, West, and Third World blocs. The task will be to study the process by which they attempt to form a cooperative international organization, which special attention to the divisive interpersonal and intergroup processes which generate conflict and interfere with cooperation.

This workshop will explore the assumptions underlying the growing field of interactive conflict resolution and will focus upon the issues involved in power asymmetries between parties. Interactive conflict resolution can be distinguished from related efforts in diplomacy and mediation by its emphasis upon transforming adversarial relationships into more cooperative ones, its sensitivity to social and psychological dimensions of conflict, its attention to basic human needs (i.e. identity, recognition, security and equity), and its promotion of collaborative problem-solving. The range of activities used by practitioners in the field includes the following: problem-solving workshop, training in conflict resolution and prejudice-reduction, and efforts to document and evaluate pre-negotiation activities.

The workshop will involve participants in an exploration of a critical yet underaddressed issue in the field--the problem of power asymmetry. The workshop will consist of a series of small and large group discussions and participatory exercises which will address the following questions: (a) How have power imbalances, such as those related to race, gender, age, resources and political status, been experienced by all parties (including facilitators)? (b) What are appropriate and successful third-party interventions in an asymmetrical negotiation or encounter?

The co-chairs of the workshop have facilitated interactive conflict resolution initiatives with Israelis and Palestinians, U.S. and Soviet citizens as well as other communal groups.

In 1992 the world faces dramatic change: the new structure of the international system, the emergence of new states, and American national elections. Both citizens and scholars are attempting to assess the qualities of men and women who seek global and national leadership positions. The Leadership Analysis Support System (LASS) provides a new and important analytic tool to assist in this process.

LASS is an expert knowledge-based software system that assists users in assessing the personality characteristics and behavior of political leaders. LASS poses over 80 questions about personality, cognitive style, political style, and decision-making style. It offers analytic guidance based on a knowledge base of rules acquired from senior clinical psychologists, psychiatrists, political scientists, sociologists, and cultural anthropologists.

A live demonstration of LASS will be presented. Participants will be encouraged to conduct LASS sessions with leaders of their own choosing, compare LASS results to their own independent assessments, and critique the LASS design. The workshop will also include a discussion of how knowledgebased systems are built, with particular emphasis on key issues that affected the design and development of LASS.
