

Hello everyone:

My colleagues and I are conducting a meta-analysis to test the Social Identity Relative Deprivation Efficacy (SIRDE) model of social change (Grant et al., 2015; Grant et al., 2018). To the extent it is possible, we will also be examining an extension of the SIRDE model called IDEAS (Abrams, et al., 2020).

To be included in our meta-analysis, the research must be studying a disadvantaged group's protest actions, future protest intentions, or militant attitudes supporting such actions (the dependent variables), including both normative and non-normative (radical) protest actions. We are also including environmental protest groups in this search.

In addition, the research MUST measure or manipulate AT LEAST ONE of the following:

- identification with the disadvantaged group/activist group;
- the intergroup emotions of anger, frustration, outrage, and/or resentment at the group's disadvantage;
- the perception that the disadvantaged group is/was treated unfairly, is/was treated unjustly, or is/was discriminated against;
- the perceived collective efficacy (including political collective efficacy) regarding the ability of the disadvantaged group to effectively address the disadvantage.

We are currently soliciting unpublished articles such as conference papers, technical reports, and unpublished papers including papers that may/will be published in 2020¹. We also would be happy to include the method section of incomplete manuscripts with sample/participant details/n, a description of the measures, and a correlation matrix and a table of means, standard deviations and reliability coefficients.

¹To date, we have used PsychINFO, SOCindex, Web of Science, and Scopus to identify and download relevant articles for the period January 2007 to December 2019. We then added articles cited by and which cite two previous meta-analyses (Smith et al., 2012; van Zomeren et al., 2008). Through this process we have already accumulated 373 articles in our data base.
